A fee will be charged to all participants. Fees are listed on the application attached.

Rules: All tables, chairs, tent, display & change must be provided by vendor No vehicles allowed on grounds

No sale of food or drink permitted

Neutral Ground space is limited and will be assigned on a first-come, first-serve basis upon receipt of paid application. The deadline, pending available space, is Saturday, October 6, 2018. Application fees are non-refundable once available space is verified and is non-transferrable. Set up may begin at 6:30 AM. All vendors must move their vehicles after unloading. No parking is allowed on the neutral ground side of the street. NO EXCEPTIONS! All vendors must stay the entire duration of the event. Breakdown cannot begin until 3:00 PM.
